Presentation Christoph Bossart, Mercator

- Budget of Mercator 13 Mio per year
- Funded projects ideally on the higher level of participation level 3 and 4: involving Citizens in problem definition and collaborating with them
- Long term support 3 to 5 years
- Payment schedule negotiated individually

Presentation Ingrid Kissling, SNF

- Mandate of SNF to fund research at universities
- o Precondition to apply for funding: job at the university at least 50%
- Possible to include partners being not from universities, openness and strategy to work with partners
- If SNF would change the precondition it would change the whole funding scheme
- In the field of communication restrictions are less AGORA scheme
- In general, less money for bottom up research other fundings or infrastructures suitable
- Universities are not interested in long term funding, however make slowly a shift
- Discussion with SWIR on long term funding
- o CS projects require more skills to manage than there is at universities

Brief input Gabriella Zinke, BAFU

- Little research at BAFU but not on Citizen Science
- Pragmatic approach: not all projects are indoors commissioned to other institutions
- Special contract mandates rather than grants



Question to all three speakers

If you are a Citizen Scientist and not in an institution – what kind of possibilities do they have to get funded?

- SNF: You need to find a job or partner at a university

- Mercator: The foundation is open to NGOs, associations, etc.

Most applications are handed in by Fachhochschulen, initiative

mostly from academic side

Most people know the short cut via universities rather than

foundations
